


The Scheme shall invest in Overseas Index Funds and/or Exchange Traded Funds ("ETFs") in accordance with Para 12.19 of SEBI Master Circular for Mutual Funds and as amended by SEBI from time to time.

Under normal circumstances, at least 95% of the Net assets of the Scheme will be invested in Units of overseas Index Funds and/or ETFs subject to the availability of Eligible Investment Amount.

Investments made for the purpose of ensuring liquidity (debt and money market instruments) are those that fall within the definition of liquid assets.

In line with Para 12.19.1.1 of SEBI Master Circular for Mutual Fund, Mutual Funds can make overseas investments subject to a maximum of US \$ 1 billion per Mutual Fund, within the overall industry limit of US \$ 7 billion or such other limits as prescribed by SEBI from time to time. Further, in line with Para 12.19.1.2 of SEBI Master Circular for Mutual Fund, Mutual Funds can make overseas investments in ETFs subject to a maximum of US \$300 million per Mutual Fund, within the overall industry limit of US \$ 1 billion or such other limits as prescribed by SEBI from time to time.

The cumulative gross exposure through units of Overseas Index Funds and/or ETFs and Debt and Money market instrument shall not exceed 100% of the net assets of the Scheme in accordance Para 12.24 of SEBI Master Circular for Mutual Funds. Cash or cash equivalents with residual maturity of less than 91 days shall be treated as not creating any exposure. SEBI vide letter dated November 3, 2021 has clarified that Cash Equivalent shall consist of Government Securities, T-Bills and Repo on Government Securities having residual maturity of less than 91 days.

The Scheme shall not invest in REIT and InVITs, Securitized Debt, Repo in Corporate Debt Instruments, Derivatives, Credit Default Swaps, Stock Lending, debt instruments having Structured obligations / Credit enhancements and instruments with special features as specified in Para 12.2 of SEBI Master Circular for Mutual Fund. The Scheme shall not undertake short selling. The Scheme will be investing in Overseas Index Funds and/or ETFs only and not directly in overseas securities.

Investment in Units of Mutual Fund

The Scheme may invest upto 5% of the net assets of the Scheme in units of debt and liquid mutual fund schemes of Axis AMC or other domestic mutual funds in conformity with the investment objective of the Scheme and in terms of the prevailing SEBI (MF) Regulations.

Investment in Short Term Deposits

Pending deployment of the funds in securities in terms of investment objective of the Scheme, the AMC may park the funds of the Scheme in short term deposits of the Scheduled Commercial Banks, subject to the guidelines issued by Para 12.16 of SEBI Master Circular for Mutual Funds.

However, the underlying Index Funds and/or ETFs may have exposure to Derivatives and Repo and Reverse repo in corporate debt securities.

Portfolio rebalancing due to short term defensive considerations:

Subject to the SEBI (MF) Regulations, the asset allocation pattern indicated above may change from time to time, keeping in view market conditions, market opportunities, applicable regulations and political and economic factors. The Scheme may actively deviate from the stated asset allocation pattern outlined in the SID during extenuating circumstances. These instances may be beyond the control of the fund manager & the AMC and hence may require such deviations. Such changes in the investment pattern will be transitional in nature and will be undertaken as defensive considerations only in accordance with Para 1.14.1.2 of SEBI Master circular for Mutual Fund and as amended from time to time. Defensive considerations may be determined by the fund manager and /or AMC from time to time. In case of deviations on account of exogenous factors, the fund manager will endeavour to rebalance the Scheme within 30 calendar days from the date of such deviation. The intention being at all times to seek to protect the interests of the Unit holders.

Portfolio rebalancing due to passive breaches:

In case of passive deviation from the asset allocation pattern or various prudential limits prescribed under SEBI (Mutual funds) regulations, 1996 and circulars issued thereunder, the AMC shall follow process specified in Para 2.9 of SEBI Master circular for Mutual Fund as amended from time to time. In line with the circular, in the event of deviation from the mandated asset allocation limits mentioned in the SID or the prudential limits due to passive breaches such as corporate action, substantial rise/ fall in the price of an underlying scrip, maturity of any underlying security, large redemptions, etc., the portfolio would be rebalanced within 30 business days from the date of deviation. Where the portfolio is not rebalanced within mandated timelines, justification in writing including details of efforts taken to rebalance the portfolio shall be placed before the Investment Committee. The Investment Committee, if so desires, can extend the timelines up to sixty (60) business days from the date of completion of mandated rebalancing period. In case the portfolio of the Scheme is not rebalanced within aforementioned mandated plus extended timelines AMC shall adhere to the requirements as laid down in the aforesaid SEBI circular. However, at all times, the portfolio will adhere to the overall investment objective of the scheme.

The corpus of the Scheme will be investing in units of overseas Index Funds and/or ETFs wherein the underlying investments comprise of US treasury securities. The underlying Index Funds and/or ETFs may also have exposure to derivatives and Repo and Reverse repo in corporate debt securities.

The Scheme will invest in following instruments:

Investment in overseas securities shall be made in accordance with the requirements stipulated by SEBI and RBI from time to time.

The Scheme shall invest in any other instruments as may be permitted by SEBI/RBI from time to time.

C. WHAT ARE THE INVESTMENT STRATEGIES?

The scheme follows an active investment strategy.

The primary investment objective of the Scheme is to provide regular income by investing in units of overseas Index Funds and/or ETFs where the investment mandate is to invest in US treasury securities across duration.

There is no assurance that the investment objective of the Scheme will be achieved.

The Scheme will seek to invest in one or a combination of overseas Index Funds and/or ETFs from the list provided under the asset allocation pattern where the investment mandate of the underlying fund will be to deploy primarily in securities issued by the US government with a residual maturity cap of up to 15 years. The investment in a fund or a combination of funds will be made with the intent to efficiently manage risks

associated with such investments and the available market opportunities.

The fund manager may actively deploy across multiple funds to achieve the intended duration profile basis his/her market view. While selecting funds, the fund manager and the AMC will evaluate various fund parameters including but not restricted to fund size, maturity profiles of the fund, fund vintage, and other parameters.

Portfolio Turnover

As the Scheme will predominantly follow an active investment strategy for investments in the overseas mutual fund, the endeavour will be to minimise the portfolio turnover subject to exigencies and needs of the Scheme. Generally, for the investments in overseas fund, the turnover will be confined to the subscriptions and redemptions (including inter-fund switches, if any) in the underlying overseas fund. However, it is difficult to estimate with any reasonable measure of accuracy, the likely turnover in the portfolio.

For domestic securities investments, there may be an increase in transaction cost such as brokerage paid, if trading is done frequently. However, the cost would be negligible as compared to the total expenses of the Scheme. Frequent trading may increase the profits which will offset the increase in costs. The fund manager will endeavor to optimize portfolio turnover to maximize gains and minimize risks keeping in mind the cost associated with it. However, it is difficult to estimate with reasonable accuracy, the likely turnover in the portfolio of the Scheme. The Scheme has no specific target relating to portfolio turnover.





Part III. OTHER DETAILS

A. COMPUTATION OF NAV

The Net Asset Value (NAV) per Unit under the Scheme will be computed by dividing the net assets of the Scheme by the number of Units outstanding on the valuation day. The Mutual Fund will value its investments according to the valuation norms, as specified in Schedule VIII of the SEBI (MF) Regulations, or such norms as may be specified by SEBI from time to time.

Valuation of Foreign Currency / Securities: On the valuation day, all the assets and liabilities denominated in foreign currency will be valued in Indian Rupees. The valuation price of the security will be converted to INR based on FBIL/any other designated agency, reference rate at the close of banking hours in India. If required, the AMC may change the source of determining the exchange rate. The Fund shall value its investments according to the valuation norms (Valuation Policy includes computation of NAV in case of investment in foreign securities), as specified in the Eighth Schedule of the Regulations, or such guidelines / recommendations as may be specified by SEBI from time to time. The broad valuation norms are detailed in the Statement of Additional Information.

The Net Assets Value (NAV) of the Units under the Scheme shall be calculated as shown below:

$$\text{NAV (Rs.)} = \frac{\text{Market or Fair Value of Scheme's Investments} + \text{Current Assets including Accrued Income} - \text{Current Liabilities and Provisions}}{\text{No. of Units outstanding under Scheme on the Valuation Day}}$$

The NAV shall be calculated up to four decimal places. However, the AMC reserves the right to declare the NAVs up to additional decimal places as it deems appropriate. Separate NAV will be calculated and disclosed for each Option.

The AMC will calculate and disclose the first NAV of the Scheme within a period of 5 business days from the date of allotment. Subsequently, the NAVs will be calculated and disclosed on all the Business Days.

Direct Plan shall have a lower expense ratio excluding distribution expenses, commission, etc. and no commission for distribution of Units will be paid/ charged under Direct Plan.

The expenses towards Investment Management and Advisory Fees under Regulation 52(2) and the various sub-heads of recurring expenses mentioned under Regulation 52(4) of SEBI (MF) Regulations can be apportioned under various expense heads/ sub heads without any sub limit, as permitted under the applicable regulations. Thus, there shall be no internal sub-limits within the expense ratio for expense heads mentioned under Regulation 52(2) and (4) respectively. Further, the additional expenses under Regulation 52(6A)(c) may be incurred either towards investment & advisory fees and/or towards other expense heads as stated above.

These estimates have been made in good faith as per the information available to the Investment Manager and are subject to change inter-se or in total subject to prevailing Regulations.

The AMC will charge the Scheme such actual expenses incurred, subject to the statutory limit prescribed in the Regulations.

The investors will bear the recurring expenses of the scheme in addition to the expenses of other scheme in which Axis US Specific Treasury Dynamic Debt Passive FOF will make investment.

In accordance with Regulation 52(6)(a) the total expense ratio of the Scheme including weighted average of the total expense ratio levied by the underlying scheme shall not exceed 1.00 per cent of the daily net assets of the Scheme.

Provided that the total expense ratio to be charged over and above the weighted average of the total expense ratio of the underlying scheme shall not exceed two times the weighted average of the total expense ratio levied by the underlying scheme, subject to the overall ceilings as stated above.

The AMC will charge the Scheme such actual expenses incurred, subject to the statutory limit prescribed in the Regulations.

- a) additional expenses, incurred towards different heads mentioned under Regulations 52(2) and 52(4), not exceeding 0.05 per cent of daily net assets of the Scheme;

GST payable on investment and advisory service fees ('AMC fees') charged by Axis Asset Management Company Ltd.;

Further, brokerage and transaction costs which are incurred for the purpose of execution of trade shall not exceed 0.12 per cent in case of cash market transactions.

- B. Within the Total Expense Limit chargeable to the scheme, following will be charged to the Scheme:
- a) GST on other than investment and advisory fees, if any, (including on "Custody Services - GST on Foreign Exchange") shall be borne by the Scheme
 - b) Investor education and awareness initiative fees of at least 2 basis points on daily net assets of the Scheme.
- C. AMC fees charged by Axis AMC to the scheme will be within the Total Expense Limit as prescribed by SEBI Regulations, as amended from time to time.

The mutual fund would update the current expense ratios on its website (www.axismf.com) on daily basis and notices for any change in the Total Expense Ratio shall be updated on website atleast three working days prior to the effective date of the change. Investors can refer 'Total Expense Ratio of Mutual Fund Schemes' section on <https://www.axismf.com/total-expense-ratio> for Total Expense Ratio (TER) details.

All scheme related expenses including commission paid to distributors, by whatever name it may be called and in whatever manner it may be paid, shall necessarily be paid from the scheme only within the regulatory limits and not from the books of AMC, its associate, sponsor, trustees or any other entity through any route in terms of SEBI circulars and clarification issued thereon.

The investors will be bearing the recurring expenses of the scheme, in addition to the expenses of other schemes in which the Fund of Funds Scheme makes investments.

Illustration: Impact of Expense Ratio on Scheme's return:

Expense ratio, normally expressed as a percentage of Average Assets under Management, is calculated by dividing the permissible expenses under the Regulations by the average net assets.

To further illustrate in rupee terms the above, for the Scheme under reference, suppose an Investor invested Rs. 10,000/- (after deduction of stamp duty and transaction charges, if any) under the Growth Option, the impact of expenses charged will be as under:

Note(s):

- The purpose of the above illustration is purely to explain the impact of expense ratio charged to the Plan(s) under the Scheme and should not be construed as providing any kind of investment advice or guarantee of returns on investments.
- It is assumed that the expenses charged are evenly distributed throughout the year.
- The expenses of the Direct Plan of the Scheme will be lower to the extent of the distribution expenses/ commission
- Any tax impact has not been considered in the above example, in view of the individual nature of the tax implications. Each investor is advised to seek appropriate advice.

D. LOAD STRUCTURE

Load is an amount which is paid by the Investor to redeem the Units from the Scheme. This amount is used by the AMC to pay commission to the distributors and to take care of other marketing and selling expenses. Load amounts are variable and are subject to change from time to time. For the current applicable structure, investors may refer to the website of the AMC (www.axismf.com) or may call at contact number **8108622211** (Chargeable) from 9.00 am to 6.00 pm (Monday to Saturday) or can contact his distributor.

Para 10.4 of SEBI Master Circular For Mutual Funds as amended from time to time has decided that there shall be no entry Load for all Mutual Fund Schemes.

Units issued on reinvestment of IDCW shall not be subject to Load. No load shall be levied on switches between options and sub-options of the Scheme.

Further, for switches between the Growth and IDCW Option, no load will be charged by the Scheme. For switches within the Scheme from Regular to Direct Plan or vice versa, no exit load shall be charged.

Exit load, if any, charged to the investors will be credited back to the Scheme net of GST. The Investor is requested to check the prevailing Load structure of the Scheme before investing.

SEBI Vide Para 10.4 of SEBI Master Circular For Mutual Funds has decided that there shall be no Entry Load for all Mutual Fund schemes.

For any change in Load structure, AMC will issue an addendum and display it on the website/ Investor Service Centres.

Under the Scheme, the AMC/ Trustee reserves the right to change / modify the Load structure if it so deems fit in the interest of smooth and efficient functioning of the Mutual Fund. The AMC/ Trustee reserves the right to introduce / modify the Load depending upon the circumstances prevailing at that time subject to maximum limits as prescribed under the Regulations.

The Redemption Price however, will not be lower than 97% of the NAV. Any imposition or enhancement of Load in future shall be applicable on prospective investments only.

At the time of changing the Load Structure:

1. The AMC shall be required to issue an addendum and display the same on its website immediately;
2. The addendum shall be circulated to all the distributors / brokers so that the same can be attached to all Scheme Information Document and Key Information Memorandum already in stock.
3. Latest applicable addendum shall be a part of KIM and SID of the respective Scheme(s).
4. Further, the account statements shall continue to include applicable load structure.

The Trustee/AMC reserves the right to change the load structure subject to the limits prescribed under the Regulations. Any change in load structure shall be only on a prospective basis i.e. any such changes would be chargeable only for Redemptions from prospective purchases (applying first in first out basis).

E. REQUIREMENT OF MINIMUM INVESTORS IN THE SCHEME

The Scheme shall have a minimum of 20 Investors and no single Investor shall account for more than 25% of the corpus of the Scheme. The aforesaid conditions should be complied with in each calendar quarter on an average basis. In case the Scheme does not have a minimum of 20 Investors on an ongoing basis for each calendar quarter, the provisions of Regulation 39(2)(c) of the SEBI (MF) Regulations would become applicable automatically without any reference from SEBI and accordingly the Scheme shall be wound up and the units would be redeemed at Applicable NAV. If there is a breach of the 25% limit by any Investor over the quarter, a rebalancing period of one month would be allowed and thereafter the Investor who is in breach of the rule shall be given 15 days' notice to redeem his exposure over the 25% limit. Failure on the part of the said investor to redeem his exposure over the 25% limit within the aforesaid 15 days would lead to automatic Redemption by the Mutual Fund at the Applicable NAV on the 15th day of the notice period. The Fund shall adhere to the requirements prescribed by SEBI from time to time in this regard.

SPECIAL CONSIDERATIONS

The investors will bear the recurring expenses of the Underlying Fund in addition to the recurring expenses charged by Axis US Specific Treasury Dynamic Debt Passive FOF.

The Scheme will invest in permissible overseas Index Funds and/or Exchange Traded Funds.

In accordance with the provisions of Para 12.19 of SEBI Master Circular for Mutual Funds as amended from time to time and further circulars issued by SEBI from time to time, Mutual Funds can make overseas investments subject to a maximum of US \$ 1 billion and overseas investments in ETFs subject to maximum US\$ 300 million per mutual fund or such limits as amended from time to time / RBI.

Such investments would be commensurate with the Scheme objectives, the limit of 5% of Net Assets and the prohibition of charging of fees shall not be applicable to investments in mutual funds in foreign countries made in accordance with the guidelines as per the above circular. However, management fees and other expenses charged by the mutual fund(s) in foreign countries along with the management fee and recurring expenses charged to the domestic mutual fund shall not exceed the total limit on expenses as prescribed under Regulation 52 (6)(a).

Scheme Specific Risk Factors

Risk factors for a Fund of Funds Scheme

The Scheme will be investing primarily in units of overseas Index Funds and/or ETFs that invest in US treasury securities. Hence the Scheme's performance may depend upon the performance of the underlying assets and the relevant Index Funds and/or ETFs in which the funds invest. Any change in the investment policy or the fundamental attributes of the underlying fund will affect the performance of the Scheme.

Investments in the underlying fund, which is a debt fund, will have all the risks associated with investments in debt and the offshore markets. The portfolio disclosure of the Scheme will be largely limited to the investments made by the Scheme.

Besides recurring expenses of the scheme, the Unit Holders shall also bear the applicable expenses of the underlying ETF(s)/Index Fund(s). Therefore, the returns for the Unit Holders of the scheme may be impacted or may, at times, be lower than the returns that a Unit Holder, who is directly investing in the same underlying ETF(s)/Index Fund(s), could obtain.

Risk Factors for the Underlying Fund

The performance of the underlying fund will be affected by several risk factors, including the following, some of which have also been disclosed by the underlying fund in its prospectus filed with the appropriate regulatory authorities.

General Risks: Past performance is not a guide to future performance and underlying fund where the Scheme has invested may be impacted generally by factors affecting securities markets, such as price and volume volatility in the capital markets, interest rates, currency exchange rates, changes in government policies, taxation laws or any other appropriate policies and other political and economic developments.

The value of investments and the income generated by them may go down as well as up. The fund Currency varies from the Investor's home currency, or where the Fund Currency varies from the currencies of the markets in which the Fund invests, there is the prospect of additional loss (or the prospect of additional gain) to the Investor greater than the usual risks of investment.

Investment Objective Risk: Investment objectives express an intended result but there is no guarantee that such a result will be achieved. Depending on market conditions and the macroeconomic environment, investment objectives may become more difficult or even impossible to achieve. There is no express or implied assurance as to the likelihood of achieving the investment objective for a Fund.

Regulatory Risk: The fund is domiciled in Ireland and Investors should note that all the regulatory protections provided by their local regulatory authorities may not apply. Additionally, the Funds will be registered in non-EU jurisdictions. As a result of such registrations the Funds may be subject, without any notice to the shareholders in the Funds concerned, to more restrictive regulatory regimes. In such cases the Funds will abide by these more restrictive requirements. This may prevent the Funds from making the fullest possible use of the investment limits.

Business, Legal and Tax Risks: In some jurisdictions the interpretation and implementation of laws and

regulations and the enforcement of shareholders' rights under such laws and regulations may involve significant uncertainties. Furthermore, there may be differences between accounting and auditing standards, reporting practices and disclosure requirements and those generally accepted internationally. Some of the Funds may be subject to withholding and other taxes. Tax law and regulations of any jurisdiction are frequently reviewed and may be changed at any time, in certain cases with retrospective effect. The interpretation and applicability of tax law and regulations by tax authorities in some jurisdictions are not consistent and transparent and may vary from jurisdiction to jurisdiction and/or region to region. Any change in taxation legislation could affect the value of the investments held by and the performance of the Fund.

Currency risk – The assets in which the underlying fund is invested and the income from the assets will or may be quoted in currencies which are different from the underlying fund's base currency. The performance of the underlying fund will therefore be affected by movements in the exchange rate between the currencies in which the assets are held and the underlying funds' base currency and hence there can be the prospect of additional loss or the prospect of additional gain to the investors greater than the usual risks of investment. The performance of the underlying fund may also be affected by changes in exchange control regulations.

Settlement Risks - Fixed income securities run the risk of settlement which can adversely affect the ability of the underlying fund to swiftly execute trading strategies. Lack of liquidity may adversely affect the ease of disposal of assets.

Country Risk – The scheme will invest in US denominated debt issued by the US Government. While the prospects of the US government remain stable today, any geo-political or domestic economic risk could have implications on investments made by the fund and ergo impact investors in the scheme.

Risks associated with investing in foreign securities/ overseas investments/ offshore securities

The scheme's ability to invest in overseas securities is subject to SEBI and RBI limits, which may change. If these limits are reached or restrictions are imposed, the scheme may be unable to invest in overseas securities. In such cases, the AMC will reallocate funds to other permissible investments as specified in the scheme document.

Index-Related Risk: There is no guarantee that the underlying ETF/Index Fund will closely track the Underlying Index or achieve its investment objective. Several Factors like market disruptions and regulatory restrictions may adversely affect the ETF/Mutual Fund's ability to adjust its exposure to the required levels to track the Index.

Passive Investment Risk: The underlying ETF/Index Fund is not actively managed, and the fund manager typically does not attempt to take defensive positions, even in declining markets.

Tracking Error/Tracking difference Risk: The underlying ETF/Index Fund may be subject to tracking error/tracking difference, which is the divergence from the Underlying Index's performance. Additionally, the ETF/Index Fund incurs fees and expenses, unlike the Underlying Index.

Financial Markets, Counterparties and Service Providers: The underlying ETFs/Mutual Funds may be exposed to finance sector companies acting as service providers or counterparties for financial contracts. During extreme market volatility, these actions during market emergencies, which could have substantial and adverse effects.

Global Financial Market Crisis and Governmental Intervention: Since 2007, global financial markets have faced significant disruption and instability, leading to governmental intervention. Regulators have implemented or proposed emergency measures, often unclear in scope, causing confusion and hindering market efficiency. Future restrictions and their impact on a Fund's investment objective are unpredictable. The effectiveness of current or future regulatory actions in stabilizing markets is unknown.

Term Structure of Interest Rates (TSIR) Risk: When ETFs/Index Funds invest in fixed income securities, their NAV is influenced by interest rate changes. A decline in interest rates generally increases the value of these securities, while a rise in interest rates typically decreases their value.

Risk of Investing in Sovereign Treasury STRIPS: Due to their structure, Sovereign STRIPS are more volatile and respond to greater extent to the interest rate changes than other fixed-income securities with similar maturities and credit quality, generally losing value when interest rates rise. Since they do not pay interest, funds may need to liquidate assets to meet income dividend distribution requirements, potentially at inopportune times.

Restrictions on Foreign Investment: Some countries impose significant restrictions on foreign investments. These may include requiring governmental approval, limiting investment amounts, or restricting investments to specific classes of securities with less favourable terms. In addition, certain countries implement quota restrictions on foreign ownership of certain onshore investments.

Valuation Risk: The sale price of a security or asset by the underlying ETF/Index Fund may differ from its valuation and the value used by the Underlying Index, especially in low volume or volatile markets, or when fair value methodology is applied due to trade suspensions or other reasons. Technological issues or errors by pricing services or third-party providers can also impact the ETF/Index Fund's ability to value investments.

Risks Associated with Derivatives: The Underlying ETF/Index Fund may use derivatives, which are leveraged instruments that can lead to disproportionate gains or losses. Using derivatives for hedging, risk management, or income generation may not always be successful, potentially reducing returns and increasing the risk of loss.

Legal Risk: OTC derivatives, repurchase and reverse repurchase transactions, securities lending, and reused collateral carry risks of termination due to bankruptcy, illegality, or changes in tax or accounting laws, potentially requiring the ETF/Index Fund to cover losses.

Securities Lending: Underlying ETFs/Index Funds may engage in securities lending, exposing them to credit risk from counterparties. If a counterparty defaults and the collateral value falls below the value of the lent securities, it could reduce the value of the underlying ETF/Index Fund.

Operational Risk: Underlying ETFs/Index Funds face operational risks from various factors, including human error, processing and communication mistakes, service provider or counterparty errors, and failures in processes, technology, or systems.

Counterparty Risk: An underlying ETF/Index Fund faces credit risk from its transaction parties and the risk of settlement default. Credit risk arises when a counterparty fails to meet its obligations, affecting derivatives, repurchase/reverse repurchase agreements, or securities lending agreements. Trading in uncollateralized derivatives increases direct counterparty exposure.

Risks associated with investments in Fixed Income Securities

Interest-Rate Risk: Fixed income securities such as government bonds, corporate bonds, money market instruments run price-risk or interest-rate risk. Generally, when interest rates rise, prices of existing fixed income securities fall and when interest rates drop, such prices increase. The extent of fall or rise in the prices depends upon the coupon and maturity of the security. It also depends upon the yield level at which the security is being traded.

Re-investment Risk: Investments in fixed income securities carry re-investment risk as interest rates prevailing on the coupon payment or maturity dates may differ from the original coupon of the bond.

Basis Risk: The underlying benchmark of a floating rate security or a swap might become less active or may cease to exist and thus may not be able to capture the exact interest rate movements, leading to loss of value of the portfolio.

Spread Risk: In a floating rate security the coupon is expressed in terms of a spread or mark up over the benchmark rate. In the life of the security this spread may move adversely leading to loss in value of the portfolio. The yield of the underlying benchmark might not change, but the spread of the security over the underlying benchmark might increase leading to loss in value of the security.

Liquidity Risk: The liquidity of a bond may change, depending on market conditions leading to changes in the liquidity premium attached to the price of the bond. At the time of selling the security, the security can become illiquid, leading to loss in value of the portfolio.

Liquidity Risk on account of unlisted securities: The liquidity and valuation of the Schemes' investments due to their holdings of unlisted securities may be affected if they have to be sold prior to their target date of divestment. The unlisted security can go down in value before the divestment date and selling of these securities before the divestment date can lead to losses in the portfolio.

Credit Risk: This is the risk associated with the issuer of a debenture/bond or a Money Market Instrument defaulting on coupon payments or in paying back the principal amount on maturity. Even when there is no default, the price of a security may change with expected changes in the credit rating of the issuer. It is to be noted here that a Government Security is a sovereign security and is the safest. Corporate bonds carry a higher amount of credit risk than Government Securities. Within corporate bonds also there are different levels of safety and a bond rated higher by a particular rating agency is safer than a bond rated lower by the same rating agency.

Settlement Risk: Fixed income securities run the risk of settlement which can adversely affect the ability of the fund house to swiftly execute trading strategies which can lead to adverse movements in NAV.

Rating Migration Risk: Fixed income securities are subject to rating migration risk, which can influence their prices due to changes in credit ratings. For example, a one-notch downgrade of a sovereign or AAA-rated issuer will negatively affect the security's price, while an upgrade of an AA+ issuer will have a positive impact.

Risk associated with floating rate securities

Basis Risk: The underlying benchmark of a floating rate security or a swap might become less active or may cease to exist and thus may not be able to capture the exact interest rate movements, leading to loss of value of the portfolio.

Interest Rate Risk: Typically, floating rate instruments have limited interest rate risk compared to fixed rate instruments. Changes in prevailing interest rates will likely affect the value of the Scheme's holdings until the next reset date, impacting the value of the Scheme's Units. The value of securities held by the Scheme generally varies inversely with changes in prevailing interest rates. The Mutual Fund Scheme could be exposed to interest rate risk due to the time gap in resetting benchmark rates and if the benchmark index fails to capture interest rate changes appropriately.

Spread Risk: In floating rate securities, the coupon is expressed as a spread or markup over a benchmark rate. During the life of the security, this spread may widen adversely, leading to a loss in the portfolio's value. While the yield of the underlying benchmark might remain unchanged, an increase in the spread over the benchmark can result in a decrease in the security's value.

Settlement Risk (Counterparty Risk): Specific floating rate assets can be created by swapping a fixed return for a floating rate return. In such swaps, there is a risk that the counterparty (who pays the floating rate return and receives the fixed rate return) may default.

Liquidity Risk: The market for floating rate securities is still evolving and can become illiquid from time to

time, impacting the scheme's investments. Government-issued floating rate securities, with coupons linked to treasury bill benchmarks or inflation-linked bonds, are less sensitive to interest rate changes compared to fixed rate securities.

Risk factors related to Taxation of overseas investments

Investors should be aware that proceeds from the sale of securities, dividends, and other income in some markets may be subject to taxes, levies, duties, or other charges, including withholding taxes. This could result in additional taxation for the Underlying ETF/Mutual Fund and the Scheme. Additional taxes or charges may apply depending on the location of the asset and its jurisdiction. The ability of the investment managers to provide tax information and audited accounts to Unit Holders depends on timely receipt of relevant information, which may cause delays.

Risk Factors associated with investments in Cash and Cash Equivalents:

Price-Risk or Interest-Rate Risk: Generally, when interest rates rise, prices of existing securities fall, and when rates drop, prices increase. The extent of this change depends on the coupon, days to maturity, and interest rate fluctuations.

Liquidity or Marketability Risk: This refers to how easily a security can be sold at or near its valuation Yield-to-Maturity (YTM). The primary measure of liquidity risk is the spread between the bid and offer prices quoted by a dealer.

Reinvestment Risk: Investments in cash and cash equivalents may carry reinvestment risk if interest rates on due dates differ from the original bond coupon, potentially leading to reinvestment at lower rates.

Pre-payment Risk: Some cash and cash equivalents allow issuers to call back securities before maturity during periods of declining interest rates. This may force the fund to reinvest proceeds in lower-yield securities, reducing interest income.

Risks associated with investing in Tri Party Repo (TREPS)

Axis Mutual Fund is a member of Securities segment and Tri-party Repo trade settlement of the Clearing Corporation of India Limited (CCIL). CCIL centrally settles all transactions in government securities and Tri-party Repo trades, reducing settlement and counterparty risks through robust risk management processes. CCIL maintains margin and default fund contributions from each member to cover potential losses from defaults.

If a clearing member fails to meet settlement obligations, the margin and default fund are used to complete the settlement. After utilizing the defaulter's margins and contributions, CCIL's own funds are used, followed by contributions from non-defaulting members if needed. This exposes the scheme to the risk of its contributions being used in case of settlement failures. Additionally, the scheme's contributions may cover residual losses from other defaulting members.

Risk factors may change if CCIL allows securities other than Government of India securities as collateral.

Risks Associated with Transaction in Units Through Stock Exchange Mechanism

Transactions in Units of the Scheme through NSE, BSE, or any other recognized stock exchange depend on the order processing and settlement by these exchanges and their clearing corporations, which are beyond the Mutual Fund's control. Additionally, such transactions are governed by the operating guidelines and directives issued by these exchanges.

The securities exchange listing the shares of the Underlying ETF/Mutual Fund may suspend or limit trading in any/all listed securities. Such a suspension could lead to losses and delays in the underlying ETF/Mutual Fund's ability to redeem shares.

Risks associated with Segregated Portfolio

1. Investor holding units of segregated portfolio may not be able to liquidate their holding till the time recovery of money from the issuer.
2. Security comprises of segregated portfolio may not realise any value.
3. Listing of units of segregated portfolio on recognised stock exchange does not necessarily guarantee their liquidity. There may not be active trading of units in the stock market. Further trading price of units on the stock market may be significantly lower than the prevailing NAV.

C. Risk mitigation strategies**Risk control measures with respect to investment in units of overseas Index Funds and/or ETFs**

Market Risk: The scheme is vulnerable to movements in the prices of US treasury securities invested by the underlying scheme, which could have a material bearing on the overall returns from the scheme. Investments in US treasury securities are subject to price fluctuation on daily basis.

Mitigation – Index Funds and ETFs being passively managed carry lesser risk compared to active management. The underlying Index Funds and ETF(s) where the Scheme intends to invest follow the underlying benchmarks and therefore the level of portfolio volatility would be same as that of the underlying benchmark. The fund manager would also endeavour to keep minimal cash levels to keep performance deviation from the underlying Index Funds and ETFs to minimal.

Currency Risk: As the underlying Index Funds or ETFs will invest in US treasury securities which are denominated in foreign currencies, fluctuations in the exchange rates of these foreign currencies may have an impact on the income and value of the underlying or ETFs. The repatriation of capital to India may also be hampered by changes in the regulations concerning exchange controls or political circumstances as well as the application to it of other restriction on investment.

Mitigation: The scheme shall have the option to enter into permissible instruments (subject to applicable regulations by SEBI/RBI) for the purposes of hedging against the foreign exchange fluctuations.

Liquidity Risk: This refers to the ease with which a security can be sold at or near to its valuation yield-to-maturity (YTM).

Mitigation: The Scheme will invest in units of the underlying scheme which will invest in US treasury securities and the liquidity risk for these units / securities will be relatively low

Risk associated with the investment objective of the underlying scheme: The scheme will invest in funds which have similar investment objectives to the domestic funds in India. However, there exists possibility that there is a change in the fundamental attributes of the underlying scheme.

Mitigation: The fund manager will seek to invest in other overseas funds, which have the same investment objective as the domestic fund.

Risk control measures with respect to Debt Investments – i.e investment in Debt, Money Market Instruments.

Market Risk / Interest Rate Risk: Changes in interest rates may affect the Scheme's Net Asset Value as the prices of securities generally increase as interest rates decline and generally decrease as interest rates rise. The price movement up and down in fixed income securities will lead to possible movements in the NAV.

Mitigation - In a rising interest rates scenario the Scheme / underlying scheme may increase its investment in money market securities whereas if the interest rates are expected to fall the allocation to debt securities with longer maturity may be increased thereby mitigating risk to that extent.

Liquidity or Marketability Risk: This refers to the ease with which a security can be sold at or near to its

valuation yield-to-maturity (YTM).

Mitigation- The Scheme / underlying scheme may invest in government securities, corporate bonds and money market instruments. While the liquidity risk for government securities, money market instruments and short maturity corporate bonds may be low, it may be high in case of medium to long maturity corporate bonds.

Credit risk or default risk: It refers to the risk that an issuer of a fixed income security may default (i.e., will be unable to make timely principal and interest payments on the security). Normally, the value of a fixed income security will fluctuate depending upon the changes in the perceived level of credit risk as well as any actual event of default. The greater the credit risk, the greater the yield required for someone to be compensated for the increased risk.

Mitigation: Apart from the basic examination, management's past track record will also be studied. In order to assess financial risk a detailed assessment of the issuer's financial statements will be undertaken to review its ability to undergo stress on cash flows and asset quality. A detailed evaluation of accounting policies, off-balance sheet exposures, notes, auditors' comments and disclosure standards will also be made to assess the overall financial risk of the potential borrower.

The Scheme will also invest in Debt Instruments, Money Market Instruments and other permitted securities subject to regulatory approvals, if any, which will include but not limited to:

Debt Instruments & Money Market Instruments

Certificate of Deposit (CD)

Certificate of Deposit (CD) is a negotiable money market instrument issued by scheduled commercial banks and select all-India Financial Institutions that have been permitted by the RBI to raise short term resources. The maturity period of CDs issued by the Banks is between 7 days to one year, whereas, in case of FIs, maturity is one year to 3 years from the date of issue.

Commercial Paper (CP)

Commercial Paper (CP) is an unsecured negotiable money market instrument issued in the form of a promissory note, generally issued by the corporates, primary dealers and all India Financial Institutions as an alternative source of short term borrowings. CP is traded in secondary market and can be freely bought and sold before maturity.

Treasury Bill (T-Bill)

Treasury Bills (T-Bills) are issued by the Government of India to meet their short term borrowing requirements. T-Bills are issued for maturities of 14 days, 91 days, 182 days and 364 days. The Scheme may also invest in Cash Management Bill (CMB) issued by the Government of India to meet their short term borrowing requirements. CMB are generally issued for maturities of less than 91 days.

Commercial Usance Bills

Bill (bills of exchange/promissory notes of public sector and private sector corporate entities) Rediscounting, usance bills and commercial bills.

Repos

Repo (Repurchase Agreement) or Reverse Repo is a transaction in which two parties agree to sell and purchase the same security with an agreement to purchase or sell the same security at a mutually decided future date and price. The transaction results in collateralized borrowing or lending of funds. Presently in India, Government Securities, State Government Securities and T- Bills are eligible for Repo/Reverse Repo.

Tri-party repo means a repo contract where a third entity (apart from the borrower and lender), called a Tri-Party Agent, acts as an intermediary between the two parties to the repo to facilitate services like collateral selection, payment and settlement, custody and management during the life of the transaction.

The Scheme may undertake repo or reverse repo transactions in accordance with the directions issued by RBI and SEBI from time to time. Such investment shall be made subject to the guidelines which may be prescribed by the Board of Directors of the Asset Management Company and Trustee Company.

Securities created and issued by the Central and State Governments as may be permitted by RBI, securities guaranteed by the Central and State Governments (including but not limited to coupon bearing bonds, zero coupon bonds and treasury bills). State Government securities (popularly known as State Development Loans or SDLs) are issued by the respective State Government in co-ordination with the RBI.

Non -Convertible Debentures

Non convertible debentures are securities issued by companies / institutions promoted / owned by the Central or State Governments and statutory bodies which may or may not carry a Central/State Government guarantee, Public and private sector banks, all India Financial Institutions and Private Sector Companies. These instruments may be secured or unsecured against the assets of the Company

and generally issued to meet the short term and long term fund requirements. These instruments may have fixed or floating rate coupon. The Scheme may also invest in the non convertible part of convertible debt securities.

Foreign Securities:

The Scheme shall invest only in Overseas Index Funds and/or ETFs.

In terms of Para 12.19 of Master Circular for Mutual Fund as amended from time to time. Mutual funds can make overseas investments subject to a maximum US \$ 1 billion and overseas investments in ETFs subject to maximum \$ 300 million per mutual fund or such limits as amended from time to time by SEBI/ RBI, and commensurate with the Scheme objectives. The Mutual Fund may also appoint overseas investment advisors and other service providers, to the extent permissible under the Regulations.

The Mutual Fund may open one or more foreign currency accounts abroad either directly, or through the custodian/sub-custodian, to facilitate investments and to enter into/deal in forward currency contracts, currency futures, interest rate futures / swaps, currency options for the purpose of hedging the risks of assets of a portfolio or for its efficient management. However, the use of such instruments shall be as permitted from time to time. All the requirements of the Para 12.19 of Master Circular for Mutual Fund as amended from time to time, would be adhered to by the AMC for investment in Overseas Index Funds and/or ETFs.

Short Term Deposits

Pending deployment of funds as per the investment objective of the Scheme, the Funds may be parked in short term deposits of the Scheduled Commercial Banks, subject to guidelines and limits specified by subject to the guidelines issued by Para 12.16 of Master Circular for Mutual Funds.

Units of Mutual Fund Schemes

The funds may also be parked in units of debt and liquid mutual fund schemes of Axis AMC or in the Scheme of other domestic mutual funds in conformity with the investment objective of the Scheme and in terms of the prevailing SEBI (MF) Regulations. Provided that such investment will be within the limits specified under SEBI (MF) Regulations and will be done for cash management purposes

The securities / instruments mentioned above and such other securities the Scheme is permitted to invest in could be listed, privately placed, secured, unsecured, rated or unrated and of any maturity.

The securities may be acquired through secondary market, private placement, rights offers, negotiated deals etc. Further investments in debentures, bonds and other fixed income securities will be in instruments which have been assigned investment grade rating by the Credit Rating Agency.

Investment in unrated debt instruments shall be subject to complying with the provisions of the Regulations and within the limit as specified in Schedule VII to the Regulations. All such investments shall be made with the prior approval of the Board of AMC and Trustee.

For applicable regulatory investment limits please refer paragraph "Investment Restrictions".

The Fund Manager may invest in any other security as maybe permitted from time to time and which are in line with the investment objectives of the Scheme.

Debt and Money Markets in India

The Indian debt market is today one of the largest in Asia and includes securities issued by the Government (Central & State Governments), public sector undertakings, other government bodies, financial institutions, banks and corporates. Government and public sector enterprises are the predominant borrowers in the markets. The major players in the Indian debt markets today are banks, financial institutions, mutual funds, insurance companies, primary dealers, trusts, pension funds and corporates. The Indian debt market is the

largest segment of the Indian financial markets. The debt market comprises broadly two segments, viz. Government Securities market or G-Sec market and corporate debt market. The latter is further classified as market for PSU bonds and private sector bonds.

The Government Securities (G-Secs) market, consists of G-Sec outstanding of Rs. 80,86,643.177 cr as on Feb 17, 2022 (State Govt securities - Rs 38,31,895.100 cr, (as on Feb'21) Source: CCIL), is the oldest and the largest component (50% share in market cap) of the Indian debt market in terms of market capitalization, outstanding securities and trading volumes. The G-Secs market plays a vital role in the Indian economy as it provides the benchmark for determining the level of interest rates in the country through the yields on the Government Securities which are referred to as the risk-free rate of return in any economy. Over the years, there have been new products introduced by the RBI like zero coupon bonds, floating rate bonds, inflation indexed bonds, etc.

The corporate bond market, in the sense of private corporate sector raising debt through public issuance in capital market, is only an insignificant part of the Indian Debt Market. A large part of the issuance in the non-Government debt market is currently on private placement basis.

The money markets in India essentially consist of the call money market (i.e. market for overnight and term money between banks and institutions), repo transactions (temporary sale with an agreement to buy back the securities at a future date at a specified price), commercial papers (CPs, short term unsecured promissory notes, generally issued by corporates), certificate of deposits (CDs, issued by banks) and Treasury Bills (issued by RBI). In a predominantly institutional market, the key money market players are banks, financial institutions, insurance companies, mutual funds, primary dealers and corporates. In money market, activity levels of the Government and nongovernment debt vary from time to time. Instruments that comprise a major portion of money market activity include but not limited to:

- Overnight Call
- Tri Party Repo
- Repo/Reverse Repo Agreement
- Treasury Bills
- Government securities with a residual maturity of < 1 year.
- Commercial Paper
- Certificate of Deposit

Apart from these, there are some other options available for short tenure investments that include MIBOR linked debentures with periodic exit options and other such instruments. Though not strictly classified as Money Market Instruments, PSU / DFI / Corporate paper with a residual maturity of < 1 year, are actively traded and offer a viable investment option.

The market has evolved in past 2-3 years in terms of risk premia attached to different class of issuers. Bank CDs have clearly emerged as popular asset class with increased acceptability in secondary market. PSU banks trade the tightest on the back of comfort from majority government holding. Highly rated manufacturing companies also command premium on account of limited supply. However, there has been increased activity in papers issued by private/foreign banks/NBFCs/companies in high-growth sector due to higher yields offered by them. Even though companies across these sectors might have been rated on a same scale, the difference in the yield on the papers for similar maturities reflects the perception of their respective credit profiles.

The following table gives approximate yields prevailing on September 30, 2025 on some of the instruments and further illustrates this point.

These yields are indicative and do not indicate yields that may be obtained in future as interest rates keep changing consequent to changes in macro-economic conditions and RBI policy. The price and yield on various debt instruments fluctuate from time to time depending upon the macro economic situation, inflation rate, overall liquidity position, foreign exchange scenario etc. Also, the price and yield vary according to maturity profile, credit risk etc.

B. What are the investment restrictions?

Pursuant to Regulations, specifically the Seventh Schedule and amendments thereto, the following investment restrictions are currently applicable to the Scheme:

1. The Scheme shall not invest more than 10% of its NAV in debt instruments comprising money market instruments and non-money market instruments issued by a single issuer, which are rated not below investment grade by a credit rating agency authorized to carry out such activity under the SEBI Act, 1992. Such investment limit may be extended to 12% of the NAV of the Scheme with the prior approval of the Trustee and the Board of Directors of AMC.

Provided that such limit shall not be applicable for investment in Government Securities, treasury bills and tri party repo on government securities.

Note: According to the Asset Allocation of the Scheme, the indicative allocation of the Scheme to Debt, Money market instruments and / or units of liquid schemes shall be in the range of 0% to 5% of the net assets of the Scheme, subject to conditions specified.

2. In accordance with the Para 12.8.3.1 of SEBI Master Circular for Mutual Fund as amended from time to time, the scheme shall not invest more than:

- a. 10% of its NAV in debt and money market securities rated AAA; or
- b. 8% of its NAV in debt and money market securities rated AA; or
- c. 6% of its NAV in debt and money market securities rated A and below issued by a single issuer.

The above investment limits may be extended by up to 2% of the NAV of the scheme with prior approval of the Board of Trustees and Board of Directors of the AMC, subject to compliance with the overall 12% limit specified in clause 1 of Seventh Schedule of MF Regulation.

The long term rating of issuers shall be considered for the money market instruments. However, if there is no long term rating available for the same issuer, then based on credit rating mapping of CRAs between short term and long term ratings, the most conservative long term rating shall be taken for a given short term

rating. Exposure to government money market instruments such as TREPS on G-Sec/ T-bills shall be treated as exposure to government securities.

Note: According to the Asset Allocation of the Scheme, the indicative allocation of the Scheme to Debt, Money market instruments and / or units of liquid schemes shall be in the range of 0% to 5% of the net assets of the Scheme, subject to conditions specified.

3.The Scheme shall not invest in unlisted debt instruments including commercial papers, except Government Securities and other money market instruments:

Provided that the Scheme may invest in unlisted non-convertible debentures up to a maximum of 10% of the debt portfolio of the Scheme subject to such conditions as may be specified by the Board from time to time:

Provided further that the Scheme shall comply with the norms under this clause within the time and in the manner as may be specified by the Board:

Provided further that the norms for investments by the Scheme in unrated debt instruments shall be as specified by the Board from time to time.

Further the investments by the Scheme shall be in compliance with Para 12.3 of SEBI Master Circular for Mutual Fund and as amended by SEBI from time to time.

Note: According to the Asset Allocation of the Scheme, the indicative allocation of the Scheme to Debt, Money market instruments and / or units of liquid schemes shall be in the range of 0% to 5% of the net assets of the Scheme, subject to conditions specified.

4.As the scheme is a fund of fund scheme, it shall be subject to the following investment restrictions:

(a)

(b) The Scheme shall not invest its assets other than in schemes of mutual funds, except to the extent of funds required for meeting the liquidity requirements for the purpose of repurchases or redemptions, as disclosed in the given Scheme Information Document.

5.The Scheme shall not invest in any other fund of funds scheme;

6.The Mutual Fund shall get the securities purchased transferred in the name of the Fund on account of the concerned Scheme, wherever investments are intended to be of a long-term nature.

7.Transfer of investments from one scheme to another scheme in the same Mutual Fund is permitted provided:

- a) such transfers are done at the prevailing market price for quoted instruments on spot basis (spot basis shall have the same meaning as specified by a Stock Exchange for spot transactions); and
- b) the securities so transferred shall be in conformity with the investment objective of the scheme to which such transfer has been made.

Further, inter scheme transfers shall be in accordance with the guidelines issued by Para 12.30 of Master for Mutual Funds as amended from time to time.

8.The Mutual Fund shall buy and sell securities on the basis of deliveries and shall in all cases of purchases, take delivery of relevant securities and in all cases of sale, deliver the securities.

9.Pending deployment of the funds of the Scheme in securities in terms of the investment objective of the Scheme, the AMC may park the funds of the Scheme in short term deposits of scheduled commercial banks, subject to the guidelines issued by Para 12.16 of SEBI Master Circular for Mutual Funds.

The Scheme will comply with the following guidelines/restrictions for parking of funds in short term deposits:

- i. "Short Term" for such parking of funds by the Scheme shall be treated as a period not exceeding 91 days. Such short-term deposits shall be held in the name of the Scheme.
- ii. The Scheme shall not park more than 15% of the net assets in short term deposit(s) of all the scheduled commercial banks put together. However, such limit may be raised to 20% with prior approval of the Trustee.
- iii. Parking of funds in short term deposits of associate and sponsor scheduled commercial banks together shall not exceed 20% of total deployment by the Mutual Fund in short term deposits.
- iv. The Scheme shall not park more than 10% of the net assets in short term deposit(s), with any one scheduled commercial bank including its subsidiaries.
- v. The Scheme shall not park funds in short term deposit (STD) of a bank which has invested in that Scheme. Further Trustees/ AMC's shall also ensure that the bank in which the Scheme has STD do not invest in the said scheme until the Scheme has STD with such bank.
- vi. The AMC will not charge any investment management and advisory fees for funds parked in short term deposits of scheduled commercial banks.

However, the above provisions will not apply to term deposits placed as margins for trading in cash market.

10. The Scheme shall not advance any loans.

11. The Scheme shall not borrow except to meet temporary liquidity needs of the Scheme for the purpose of repurchase/redemption of Units or payment of interest and/or IDCW to the Unit holders.

Provided that the Fund shall not borrow more than 20% of the net assets of the individual Scheme and the duration of the borrowing shall not exceed a period of 6 months.

The Scheme will comply with the other Regulations applicable to the investments of Mutual Funds from time to time.

12. The Mutual Fund/AMC shall make investment out of the NFO proceeds only on or after the closure of the NFO period. The Mutual Fund/ AMC can however deploy the NFO proceeds in TREPS before the closure of NFO period. However, AMC's shall not charge any investment management and advisory fees on funds deployed in TREPS during the NFO period. The appreciation received from investment in TREPS shall be passed on to investors.

Further, in case the minimum subscription amount is not garnered by the scheme during the NFO period, the interest earned upon investment of NFO proceeds in TREPS shall be returned to investors, in proportion of their investments, along-with the refund of the subscription amount.

The exposure limit/ investment restrictions prescribed under the Seventh Schedule of the Regulations and circulars issued there under (wherever applicable) shall be applicable to repo transactions in corporate bonds.

The Scheme will comply with the other Regulations applicable to the investments of Mutual Funds from time to time.

Apart from the investment restrictions prescribed under SEBI (MF) Regulations, the fund may follow any internal norms vis-à-vis limiting exposure to a particular scrip or sector, etc.

All the investment restrictions will be applicable at the time of making investments.

The AMC/Trustee may alter these above stated restrictions from time to time to the extent the Regulations change, so as to permit the Scheme to make its investments in the full spectrum of permitted investments

for mutual funds to achieve its respective investment objective.

C. Fundamental Attributes

Following are the Fundamental Attributes of the scheme, in terms of Para 1.14 of SEBI Master Circular for Mutual Funds:

However, the said rebate is not available on incomes chargeable to tax at special rates (for eg. capital gains under section 111A, 112 etc.).
